Regular patrols are made of the parking areas, and vehicles illegally parked are subject to citation. Students parking in handicap spaces and fire lanes will be fined more severely or towed and may be cited by local law enforcement. Vehicles parked in a no-parking zone or blocking dumpsters, driveways or automobiles are subject to a fine or towing. Commercial towing companies are permitted under law to charge a full towing fee when they attach a vehicle to the wrecker even if the vehicle is not moved. The University is not responsible for damage incurred to a vehicle while parked on Lee University property.

Parking citation fines must be paid in the Business Office within fifteen business days of issue date. Failure to pay a parking fine by the tenth business day will result in a non-refundable late fee of \$20 which will be added to the student's account along with the unpaid parking fine. Citation appeals must be submitted within fifteen business days of the issue date via the Citation Appeal link at www.leeuniversity.edu/security. Fines and/or appeals are solely the student's responsibility.
